Introduction

Contingency Management (CM aka Motivational Incentives) is an evidence-based treatment for substance use disorders. CM is based on the learning principle that a behavior, e.g. abstinence from substances, will increase if it is followed by a reward.

CM involves frequent monitoring of the behavior and immediate delivery of a reward when the behavior is verified to have occurred. In addition, the size of the reward increases with consistent performance of the behavior, e.g. verified by consecutively negative toxicology tests. When the behavior is not verified, i.e. toxicology results are not-negative or a sample is not provided for testing, then no reward is earned and the amount of reward re-sets to the initial size. The typical CM monitoring schedule is 12 weeks of twice or thrice-weekly toxicology testing to verify abstinence from substance(s).

The Contingency Management Template guides the end – user through the CM protocol, allowing consistent documentation and supporting adherence to the protocol. The template also provides an option to document absences if the patient does not come to the appointment.

2. Setup of Note title

You will need to create a new note title for the dialog included in this update to be attached to.

The new note title that needs to be created is:

ADDICTION TREATMENT CONTINGENCY MANAGEMENT NOTE

3. Associate the reminder dialog with the note title in CPRS.

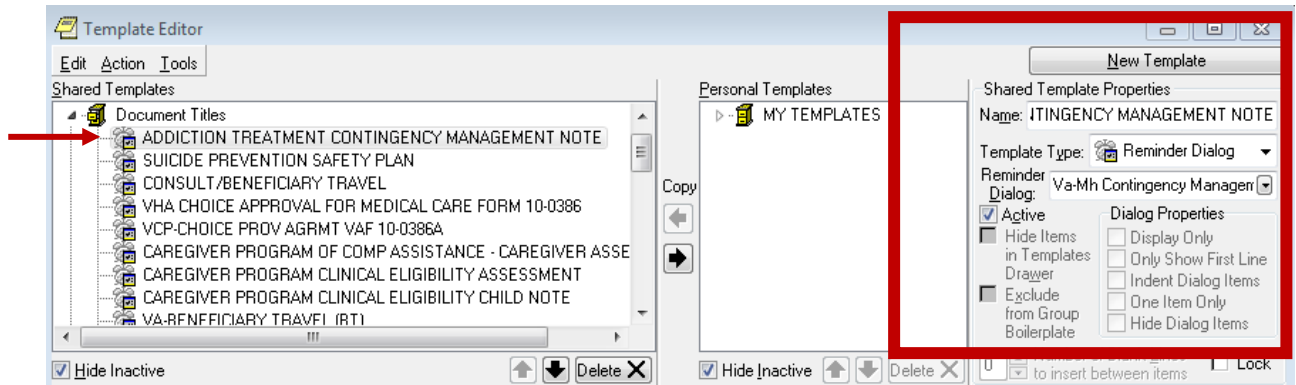
To do this, go to Template Editor, then Document Titles, select the appropriate folder (if applicable), and choose New Template (top right-hand corner).

1. Type in the following information:

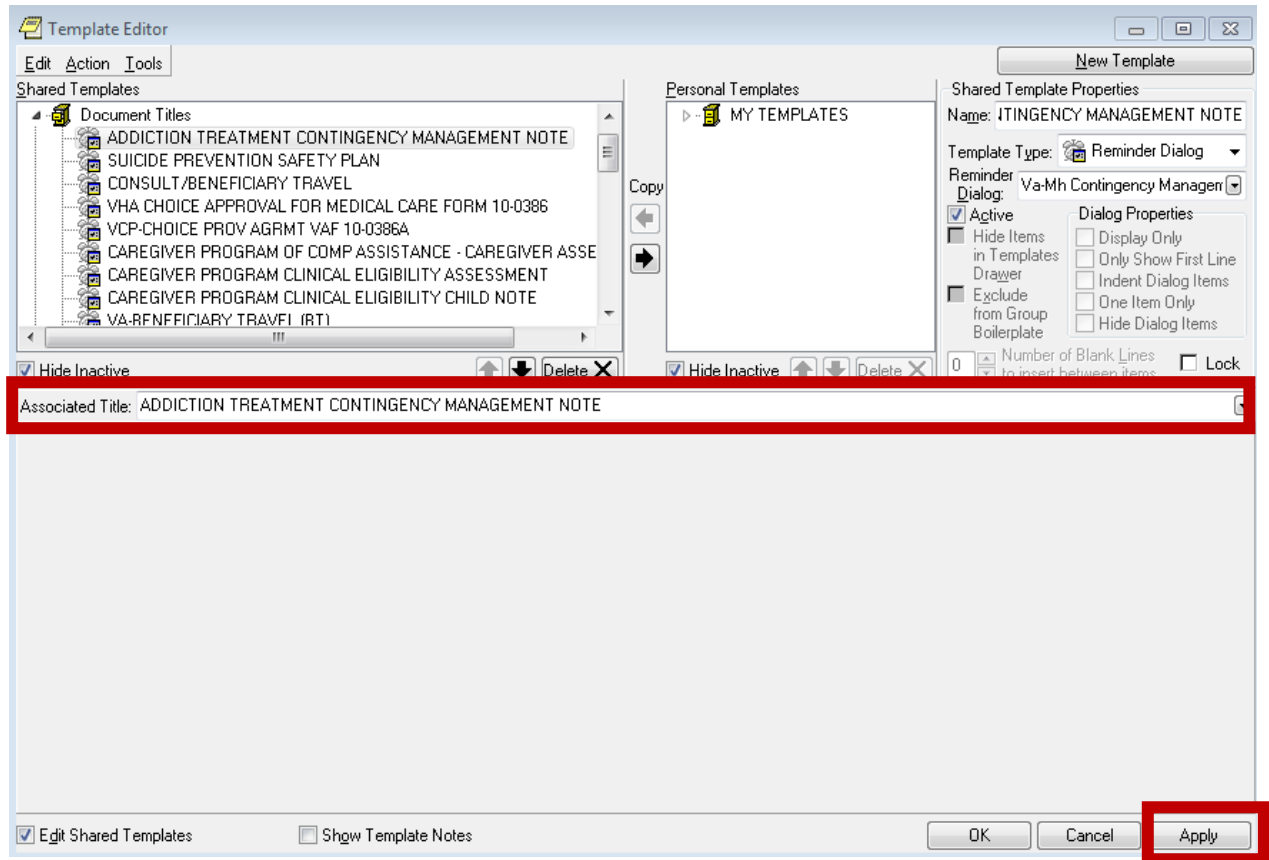
Name: **ADDICTION TREATMENT CONTINGENCY MANAGEMENT NOTE**

Template Type: Reminder Dialog

Reminder Dialog: **VA-MH CONTINGENCY MANAGEMENT**



Next, type in the Associated Title, which in this case is **ADDICTION TREATMENT CONTINGENCY MANAGEMENT NOTE**, and hit Apply:
