3. **VA-ADNS WHY NOTIFY (E) (Reminder dialog element)**



### VA-ADNS WHY NOTIFY (E) (Reminder dialog element)

A site reported that two hyperlinks in the VA-ADVANCE DIRECTIVE NOTIFICATION AND SCREENING reminder dialog are no longer working. The hyperlinks are contained in TIU TEMPLATE FIELDS “VA-ETHICS-FORM 10-0137A” and “VA-ETHICS-FORM 10-0137B” and are part of the dialog text in dialog elements “VA-ADNS WHY NOTIFY (E)” and “VA-ADNS HOW NOTIFY (E)”. These two hyperlinks reference VHA FORM 10-0137A and 10-1037B. The two broken hyperlinks are:

In the reminder exchange entry, we will only be sending out an updated element “VA-ADNS WHY NOTIFY (E)”. This will also repair the hyperlinks in “VA-ADNS HOW NOTIFY (E)”.

When installing the exchange entry is prompted for an ACTION, you should use **OVERWRITE**. This will be part of the overall INSTALL of the reminder exchange entry for this UPDATE. Please see install example. CPRS must be restarted for the changes to take place.

*Note that during installation you could possibly see errors in your error trap due to clinical reminders being evaluated as it is being installed.*

### Prior to install

1. Print or save the reminder definition VA-TBI Screening for comparison after installation
2. Review finding item on the below elements: VA-TBI OI CONSULT FOR KNOWN TBI, and VA-PDIQ POLYTRAUMA CONSULT ELEMENT for comparison after installation

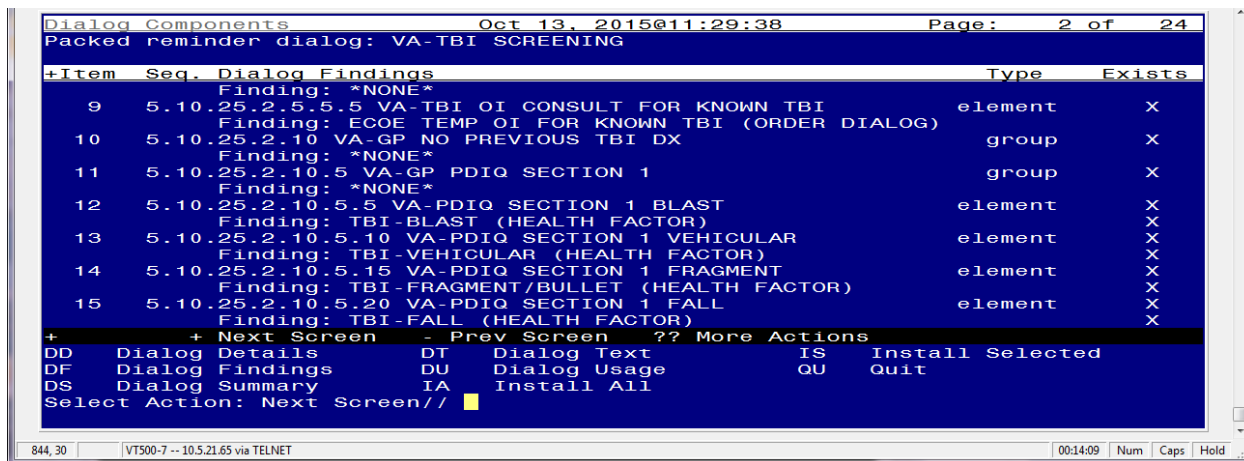

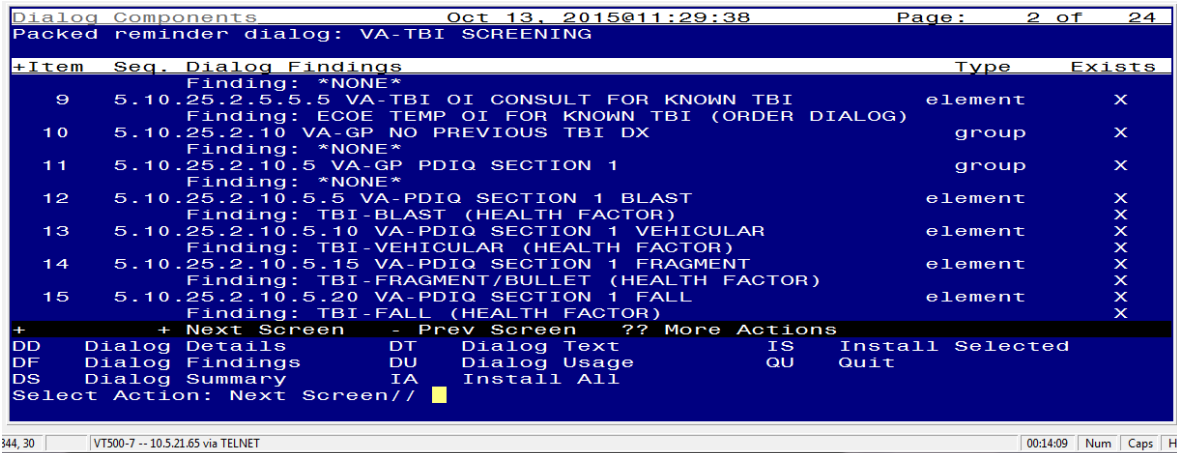
