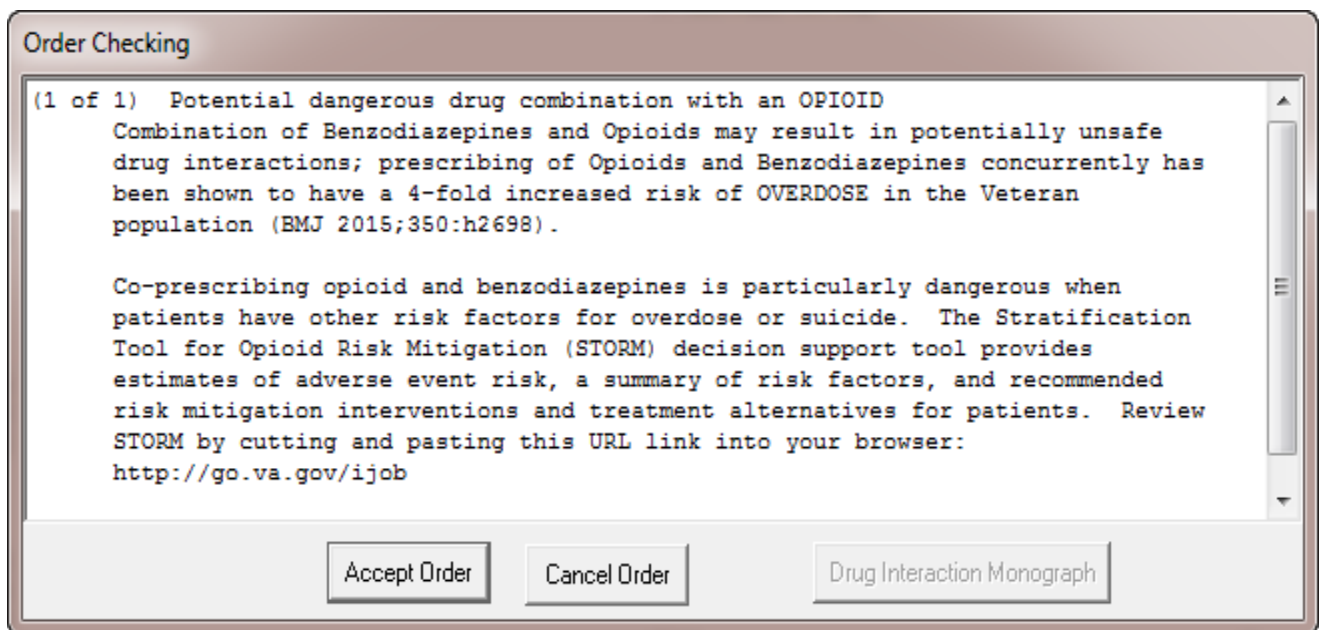
Introduction

Clinical Reminder UPDATE_2_0_11 contains 1 Reminder Exchange entry:

UPDATE_2_0_11 BENZODIAZEPINE/OPIOID ORDER CHECK

The benzodiazepine/opioid combinations Clinical reminder Order Check (CROC) will display when a provider is adding an item in one of those drug classes onto a patient's medication profile that already has the other. In order to reduce alert fatigue, the order check does not trigger for a patient already receiving both a benzodiazepine and an opioid.

Below is an example of the order check:



Note: There is a web address in the clinical reminder order checks (CROC) that connects to the Stratification Tool for Opioid Risk Mitigation (STORM) decision support tool, <http://go.va.gov/ijob>. **Due to the current functionality of CROCs, it is not possible for the user to click on the hyperlink directly within the order check text, they must copy and paste it into their web browser.** If you would like, you can add this link to your CPRS toolbar or encourage your providers to save this website in their "favorites" to make it easier for them to access.

Navigate to the exchange entry named **UPDATE_2_0_11 BENZODIAZEPINE/OPIOID ORDER CHECK** using SL Action. Once you find your entry, you will use IFE Action to install the entry. In this example, entry 54 will be used to install, it will vary by site.

Post Install Instructions

1. *Activate the Reminder Order Check Rules*

The installation of CLINICAL REMINDER UPDATE_2_0_11 will require the STATUS of the Reminder Order Check Rules “VA-BENZODIAZEPINE DRUG CLASS (CN302) (RULE)” and “VA-OPIOID DRUG CLASS (CN101) (RULE)” be changed to PROD. Shown below are the steps to make this change, which should be done for both rules.

The option represented here is **Add/Edit Reminder Order Check Rule [PXRM ORDER CHECK RULE EDIT]**.

NOTE: the STATUS property is for a specific Clinical Reminder Order Check (CROC). This is separate from the setting of Enabled/Disabled for ALL CROCs which is shown below as ‘Clinical Reminder Live’ on the Order Checks Tab of the CPRS Options screen. Individual providers cannot enable or disable individual CROCs separately.

It is therefore recommended that these order checks are enabled for all users, and set to ‘mandatory’ by the Clinical Application Coordinator (CAC) using the option ‘Set Order Checks to be Uneditable By Users [ORK EDITABLE BY USER]’. If there are users with the Clinical Reminder Live order check set to disabled when the setting is made mandatory/uneditable, the CAC can manually enable it for those users with option ‘Enable/Disable an Order Check [ORK PROCESSING FLAG]’.
