Introduction

Many changes have been made to the MH clinical reminders and associated dialogs. We have also included a new national follow up reminder for positive PTSD/Depression as a combination clinical reminder and associated dialog. The follow-up for positive alcohol screen dialog has been updated completely to the DSM5 language.

DEPRESSION SCREENING

REQUIREMENTS: Effective October 1, 2016, the PHQ-2 is the required instrument for the purpose of completing annual screening for depression.

BACKGROUND:

VHA implemented annual screening for depression as a requirement for patients active in primary and MH care starting in 2002. Over time, the requirements have been modified, and the national clinical reminder is being updated to match current performance measure requirements.

In 2006, VA implemented a two-step screening approach, utilizing the PHQ-2 as the accepted screening instrument, and following positive screens with a PHQ-9. However, this proved to be very burdensome to staff, with complexity sufficient to interfere with effective screening. Requirements were modified to allow either the PHQ-2 or the PHQ-9, but all administrations of the selected screening instrument that are positive require a suicide risk evaluation.

In support of measurement based care in treatment of depression, the PHQ-9 is being utilized as the symptom monitor for depression. This means that patients being treated for depression are receiving regular PHQ-9's as part of their routine depression care. Initial implementation is occurring in FY17, but this will be expanded to all sites over time. Sites that have used the PHQ-9 as their screening instrument for depression are experiencing problems when administrations of the PHQ-9 used for clinical symptom monitoring trigger a requirement for suicide risk evaluation.

RATIONALE: VHA depression screening requirements are to screen for depressive symptoms at the overall population level. For this purpose, the PHQ-2 has been demonstrated to be a valid and reliable instrument that works as well as the PHQ-9 or other, longer instruments. The argument can certainly be made that a longer instrument gives more information, but it is important to weigh a number of variables, including the purpose of the assessment, the value added by the additional questions versus the burden on providers and patients, and what you are going to do with the information. It is important to recognize that this is a high level screen, and all positive screening results require a follow-up assessment for depression that includes a suicide risk evaluation. This screen is to detect the presence of depressive symptoms. It is not intended to be sufficient to make a diagnosis of depression or screen for suicidal ideation.

VA-FOLLOW-UP POS PTSD/DEP COMBINATION: (new)

1. This definition was added as a national replacement for the 2 reminder definitions/dialogs that are possibly being used at your site. This reminder will be DUE NOW if *either* the Depression Screen or the PTSD screen are positive. The dialog uses branching logic to guide the users based on patient data in their chart. It was decided to streamline reminders by combining into 1 definition/dialog. The 2 definitions this replaces are below. You may not have these in your system as they are NOT national content.
 - a. EVALUATION OF + DEPRESSION SCREEN
 - b. EVALUATION OF + PTSD SCREEN

4. Added new branching logic to require offer of treatment for pts with score of >7 and AUD diagnosis.
5. Added new branching logic to toggle display of safe drinking limits based on gender
6. Removed VA-GP ALC SCREEN and replaced with VA-GP ALC OFFER TREATMENT to give providers multiple options for pts instead of just referral to specialty treatment programs
7. Part of the cohort logic is for patients with AUD diagnosis within last year and any AUDC score greater than 0 but less than 5

This update can be loaded with users on the system. Installation will take less than five minutes.

Note: You may not see exactly what is listed in the install example. The rules to follow are:

1. Print or save a copy of the reminder definition inquiries prior to installing.
2. If there is a new component, use the INSTALL action.
3. If there is an existing TERM, but the incoming one is different, use the MERGE action. This will keep you from overwriting your mapped items in the term.
4. If a component, **other than a TERM** exists, but the incoming one is different, use the OVERWRITE action.
5. There is a known bug when installing taxonomies. You will be prompted that the component is different regardless of whether it is or not. Always use the OVERWRITE action. If the taxonomy is new, use the INSTALL action (see item 2 above)
