Introduction

UPDATE_2_0_56 contains 1 Reminder Exchange entry: UPDATE_2_0_56 VA-QT PROLONGING MEDICATIONS ORDER CHECK

New Service Request "Bring QT interval as a field into CPRS and Pharmacy for Orderchecking" was submitted in February 2011 with the idea for the QT interval to be used as an input in evaluating an order check.

QT interval range is an EKG (electrocardiogram) parameter that represents electrical depolarization and repolarization of the left and right ventricles of the heart. This interval is measured to determine heart rhythmic rates. QT interval range prolongation can lead to ventricular arrhythmias which can potentially lead to sudden death. There are hundreds of drugs that can cause QT prolongation.

Currently, in order for a provider to recognize if a patient has an existing prolonged QT interval when ordering medications in CPRS, that provider must access the patients EKG results externally from CPRS, by using VistA Imaging to review the QT interval range, which is pulled from MUSE cardiology information system. A provider treating a patient with prolonged QT interval for other than cardiology reasons, might not be aware that the patient has this problem and could prescribe a medication unbeknownst to the potential health risk. Therefore, it would be desirable to have an order check that alerts providers attempting to prescribe a medication found to prolong QT interval of patient who already has a prolonged QT interval range.

Some of the underlying reasons for this request can now be achieved with CROCs (Clinical Reminder Order Checks). Specifically, patients with existing prolonged QT interval due to Long QT Syndrome (ICD10: I45.81 plus several SNOMED codes) can now have an order check presented upon an attempted order for drugs known to prolong the QT interval themselves. This reminder content update provides the VA-LONG QT SYNDROME order check for use in VistA Systems.

Post-Install Set-up Instructions

1. Activate the Reminder Order Check Rule

The installation of CLINICAL REMINDER UPDATE_2_0_56 will require the STATUS of the Reminder Order Check Rule "VA-LONG QT SYNDROME (RULE)" be changed to PROD. Sites are recommended to present this order check to the appropriate facility council or governing board with input from Cardiology Service, Pharmacy Service and the Clinical Reminders Manager for approval to enable it. Shown below are the steps to make this change if yours does not show that PROD status.

The option represented here is **Add/Edit Reminder Order Check Rule [PXRM ORDER CHECK RULE EDIT].**
