2. DO NOT install patch PSX\*2\*77 when prescriptions are being transmitted to CMOP. Wait for the CMOP transmission to finish or complete the installation before the transmission starts

No options need to be disabled.

### Installation Instructions

- 1. Choose the PackMan message containing this patch.
- 2. Choose the INSTALL/CHECK MESSAGE PackMan option.
- 3. From the Kernel Installation and Distribution System Menu, select the Installation Menu. From this menu, you may elect to use the following options. When prompted for the INSTALL NAME, enter PSX\*2.0\*77.
  - a. Backup a Transport Global This option will create a backup message of any routines exported with this patch. It will not backup any other changes such as DD's or templates.
  - b. Compare Transport Global to Current System This option will allow you to view all changes that will be made when this patch is installed. It compares all components of this patch (routines, DD's, templates, etc.).
  - c. Verify Checksums in Transport Global This option will allow you to ensure the integrity of the routines that are in the transport global.
- 4. From the Installation Menu, select the Install Package(s) option. When prompted for the INSTALL NAME, enter PSX\*2.0\*77.
- 5. When prompted "Want KIDS to INHIBIT LOGONs during the install? NO//" respond NO.
- 6. When prompted "Want to DISABLE Scheduled Options, Menu Options, and Protocols? NO//" respond NO.
- 7. If prompted "Delay Install (Minutes): (0 60): 0//" respond 0.
