## **Release Notes**

### Dent\*1.2\*59 SEQ #59, dentalmrmtx V6.0.59.97

#### **Enhancements**

- A. Users will now be guided through exam elements to enter required information for CDT codes D0120, D0140, D0150, D0160, D0170, D0180 and D9310 using a new tab in DRM Plus. Based on the code, data elements are marked as required or optional. The new tab interfaces automatically with existing DRM Plus components (Head/Neck for example) for easy entry. The GUI will generate a progress note for the visit with all exam information, along with any other DRM Plus note objects, e.g. dental alerts, etc. This functionality has also provided two user configurable parameters to change the functioning of the back and next button within the exam tab elements. This allows users to progress through all elements or only required elements and return to the previous element or the previous required element.
- B. Added new components for Occlusion, OHA (Oral Health Assessment), Parafunctional Habits, TMJ and Social History and created five new modal screens for these components. Data entered into these screens are used in the new exam elements. Users can look up previous data by date via drop down menus on these screens. Added new fields in file TREATMENT PLAN TRANSACTION/EXAM (#228.2) to store this data.
- C. The old DRM Plus component Plaque is now integrated into the new DRM Plus component OHA.
- D. The old DRM Plus component Sequencing has been renamed to Seq Plan.
- E. The old DRM Plus component History has been renamed to Chart Hx on the Treatment & Exam screen.
- F. Access to the VA Vitals-Lite application is now available from the banner in DRM Plus, the Tools menu in DRM Plus and the Vitals exam element allowing users to enter vitals.
- G. Clinical Reminders that display in CPRS for the user that are due for the selected patient will prompt a pop-up screen stating 'Clinical reminders due.' via a new icon on the DRM Plus banner. Users must still process the Reminders using CPRS.
- H. Changes were made to the Unfiled Data Report for DRM Plus Administrators. Administrators will be able to delete unfiled data for all patients. This report allows the administrator to view most details of an unfiled data entry on the report. Non-admin users will be able to delete and view their unfiled data for any patient with this report as well.
- I. The unfiled data report includes print functionality to a default printer.
- J. The pop-up screen that allows the users to load or not load unfiled data when opening DRM Plus now has a view or delete button so that unfiled data may be deleted for the patient/provider. If a user decides to view the data, to load the data they must reload the patient chart from the File Menu. Users are no longer required to reload a patient chart from CPRS.
- K. Clean slate functionality has been added to clear the graphical portion of DRM Plus for DRM Plus Administrators. Clean slate can be undone if there have been no transactions entered since the change. Clean slate removes all graphics, but leaves the transactions in the transaction table. Fields were added to TREATMENT PLAN TRANSACTION/EXAM (#228.2) to make graphics

invisible and to allow the user to undo clean slate. Once clean slate has been optioned for a patient, an icon displaying the date of the clean slate will appear in the DRM Plus banner of the selected patient. Clean slate will also delete planned care transactions, as well as inactivate unfiled data. The inactive unfiled data can be viewed, printed or deleted.

- L. DRM Plus will no longer default to maximized on reload. The functionality was changed to allow the window position to be saved as a user setting and once DRM Plus is restored it will return to the last saved position.
- M. Users will now have the ability to add canned statements for use in the five sections of the four exam elements. They are allowed 12 total for each section of the four elements: Radiographic Findings, Assessment/Plan, Patient Education, and Disposition. The administrator may also select a maximum of twelve for use in the dental clinic. The comments added by the administrator supersede those of a user. If an administrator sets eight, the user has only four available for their use.
- N. Dental Clinics in file 225 can now be flagged inactive using Fileman via a new INACTIVE (#.04) field. This will remove the clinic from selection when filing data. Remedy ticket HD0000000325041.
- O. Users may refresh patient information directly from DRM Plus from the File menu.
- P. Historical H&N information may now be entered.
- Q. Added an RPC to determine a provider's class to help manage hygienist and dentist workloads.
- R. Unfiled transactions stored longer than 8 days will be inactivated. The data can still be viewed, printed, and deleted but cannot be loaded into the patient chart.
- S. A new button called 'Screening Negative' on the Head/Neck screen will enter a canned statement into the H&N transactions.
- T. A new user setting has been added for automatic display of the help screens which include specific requirements for the exam elements and definitions for the OHA modal. The setting default is turned on to assist users completing the new exam element requirements.
- U. Dental providers with the person class of Dental Hygienist will not be able to file radiographic or exam CDT (dental procedure) codes. Dental Hygienists will be prompted to save these codes, if entered, to another dentist provider before completing an encounter.

#### **Bug Fixes**

- 1. Fixed the Provider Summary and Visits by Provider reports when Distributed Providers are included for a search by Create Date. An incorrect cross-reference was being used causing data to not be reported for hygienists. Remedy ticket HD268184.
- 2. Import medications will retrieve active with suspended or active without suspended medications into DRM Plus progress notes/consults based on user selection. Remedy tickets HD286933 and HD321886.
- 3. Missing teeth will only import into the DRM Plus progress note if there are other diagnostic findings, not for every note.
- 4. Removed a trigger for field DATE DELETED (#1.03) in file TREATMENT PLAN TRANSACTION/EXAM (#228.2) that was causing visit dates to be deleted erroneously related to the undelete fix in patch 57. The post install will loop through the file and re-add the visit date for any

records missing the VISIT DATE.

- 5. The Fluoride Monitor Prescription Date calendar is holding the date from the previous patient if entered. It now should default to todays date when entering new data. The date can also be cleared.
- 6. Removed RPC DENTV TIU GET TEMPL DATA and replaced with TIU TEMPLATE GET TEMPLATE in DENTV DSS DRM PLUS menu options to comply with ICR 5514. This RPC provides the same functionality. This fix requires TIU\*1\*252.
- 7. Changed the Provider modal from "desktopcenter" to "screencenter". The window will no longer show up in the middle of two screens when using dual monitors.
- 8. Fixed a whitespace issue in alerts. DRM Plus will no longer record whitespace or any non-visible ASCII character 0-128. Also fixed wrapping in the Alerts pop-up.
- 9. Added functionality to the transaction table to remove any incorrect displays. Moved the "Condition" above aspect, IsJuvenile, Tooth, and IsJuvenile in the component.
- 10.An Implant can be added correctly after transaction is "Invalidated" by a user.
- 11.Removed post and core from graphic when a retained root is removed.
- 12.Removed surface markers when a post and core is added.
- 13. Fixed a problem where the notes for tooth #1 could be deleted without editing the note.
- 14. Fixed labels for periodontal statistics view.
- 15. Added Close button to mesial/distal selection pop-up.
- 16. The current selected icon will remain active after canceling the ADA code selection box.
- 17. Changed the edentulous button to remove retained roots.
- 18. Allow removal of dentures, partials, bridges, and connecting bars using the missing button.
- 19. Changed connecting bar to be a single transaction; removed selection of abutments and pontics for each tooth.
- 20.Added parameter to BeginMulti event which indicates number of transactions forthcoming. This aids in the coordination of events between the component dll and the exe.
- 21.Refresh internal periodontal data when DRM Plus calls Refresh. This prevents the summary view of showing the previous patient's periodontal data.
- 22. The length of the sequencing sub-phase name is limited to 20 characters.
- 23. The ADA Codes, CPT Codes, Quick Codes buttons will be de-selected after the user clicks exit.
- 24. Retro can always be added to a root with an apicoectomy.
- 25. Search results using Add box always show updated matches.

- 26.After searching for a partial code in the Add box and selecting a code, the code will be entered on the current screen, not the user's default screen.
- 27. Panels on the DRM Plus banner have been adjusted so that clicking anywhere on the panel processes the action.
- 28. The Broker History screen was redesigned to include time stamps on RPC calls.
- 29. The Broker History will now include more than 50 calls if a user selects to retrieve more than 50.
- 30.A resident may now enter an addendum on a signed or cosigned note.
- 31. Fixed the manual HL7 resubmission process to only reset Completed transactions.
- 32. Fixed a bug in the VistA DENTV INACTIVATE PATIENTS option where the user could not use ^ to exit the option without processing.
- 33. Transactions that were "undeleted" by the post-install in patch 57 inadvertently had the Visit Date in the transaction deleted preventing the transaction from being "seen" by the exam monitor. A post-install in patch 59 will correct the Visit Date.
- 34. Fixed a bug allowing a D0140 and/or a D0170 to be entered with a D0120 or any other exam code more than once per visit.
- 35. Fixed not being able to delete all of the Adjunctive Medical Codes on the cover page. The problem only occurred when trying to delete all of the codes at the same time.
- 36. Fixed the ability to set an extract folder for non-admin users when they are granted the option to extract history reports.
- 37. The Recare report options have been ghosted out for all non-admin providers so those providers cannot run the report. Admin users are only allowed to select the All Provider option.
- 38. Fixed the Dental Alerts header from displaying when no Dental Alerts are imported into the progress note. The header will only import when there are Dental Alerts imported.
- 39.Extracted roots will now show up under Missing Retained Roots in the progress note.
- 40. Fixed an out of bounds error from occurring under certain conditions while completing sequencing transactions.
