# 2.3. Disabled Nursing [NUR] Extracts and Associated Reports

- Nursing (NUR) is removed from Fiscal Year Logic (DSS Testing Only) [ECX PRO LAB REPORT]
- Disabling NUR Extract and the associated reports updates will occur during the after installation and will change the INACTIVE field of the EXTRACT DEFINITION file to "YES" which will indicate NUR is inactive.
- NUR has been removed from the 'Print Feeder Keys' and 'Print Feeder Location' reports.
- The option 'Nursing Extract' [ECXNURS] has been removed from the 'Package Extracts' menu and has been marked 'out of order'.
- The option 'Nursing (NUR) Extract Audit' [ECX NUR SOURCE AUDIT] has been removed from the 'Extract Audit Reports' menu and has been marked 'out of order'.

#### 2.4. Removed Dental [DEN] Audit Reports

- The Dental [DEN] Extract Audit [ECX DEN SOURCE AUDIT] Report has been removed.
- All 'Dental' Feeder Locations have been removed from Print Feeder Locations.

# 2.5. Modified Lab Results Extract (LAR) Untranslatable Results Report

- Report has been truncated due to a difference in field lengths between the report and LAR extract programming.
- The number of characters for the result field has been increased from 17 to 20 characters.

#### 2.6. Exportable New Clinic Review Report

- Clinic Review Report [ECX CLINIC REVIEW REPORT] has been delineated so it can be imported into an Excel spreadsheet and will be created using the ECX Clinic Review Export (DSS clinic review output.xls) print template.
- The 'EXPORT TO TEXT FILE FOR SPREADSHEET USE' has been added as a new selection under the 'Clinics and DSS Stop Codes Print' option.

### 2.7. Prosthetics [PRO] Error Reporting Change

• The Prosthetics DSS Extract has been modified to remove sending of an error message when the HPCS field is null.

#### 2.8. Addition of Feeder Location value to Prosthetics [PRO] Extract

- Added Feeder Location value for Home Oxygen (XXXXXHO2), where the XXXXX represents the 3 to 5 character station code plus the characters HO2.
- This additional Feeder Location has been added to the current Feeder Location values of XXXXXORD, XXXXXLAB XXXXNONL.
